MINUTES OF THE ANNUAL GENERAL BODY MEETING (AGM-2018) OF IDST-HYDERABAD HELD ON 16.09.2018

3. Prof. Shri Bhagavantam Memorial Lecture Series

The Chairman gave introduction of the Guest Speaker Sri Vidyadhar Rao. The Guest Speaker delivered the memorial lecture on "Electro Static Discharge Phenomenon" with practical and visual demonstrations. The talk was very well received and appreciated by the members. The feedback was very good.
